Our Health Law & Policy Certificate Program is a collaboration between the UNH School of Law, UNH's College of Health and Human Services, and its Institute for Health Policy and Practice. You will gain an understanding of the health care marketplace through a focused core curriculum and the opportunity to select optional course credits, legal residencies, capstones, and other independent projects that result in a complete and interdisciplinary health law experience.

Our courses will focus on health care regulation, bio-ethics, current issues in health policy, and issues affecting the health law field. You will gain an understanding of the health care marketplace and have the opportunity to graduate with the legal and regulatory essentials necessary to practice in the emerging and dynamic field of health law. With up to three credits of the certificate coursework requirements available to come from a legal residency or law school clinic, there are ample opportunities for critical hands-on experience.
