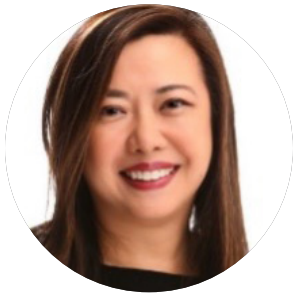

Often the media describes this issue focusing solely on patent rights, and while those are a part of the issue, there are many other legal and economic issues that affect worldwide distribution of novel medical drugs and treatments. **PETER LANDO JD '91** is a Partner at Lando Anastasi, LLP, a mid-size IP Boutique in Boston. He is a 1991 graduate of UNH Franklin Pierce Law and serves as co-chair of the Dean's Advisory Board. Peter's practice involves all areas of intellectual property and related transactions. He is routinely involved in due diligence investigations for acquisitions and divestitures of IP portfolios, involving new businesses to companies valued at more than \$1 billion, and he has been the primary negotiator or lead counsel in dozens of licensing and related business transactions. He frequently prepares patentability and freedom-to-operate opinions and has prosecuted a significant number of patents that have been successfully enforced in court and/or licensed. In addition, Peter has provided creative trademark counsel resulting in unique registration and enforcement strategies.

**MICKY MINHAS** is Senior Vice President at the Marconi Group, an intellectual property licensing and investment firm based in Dallas, Texas. As part of the Marconi management team, he plays a vital role supporting Marconi's vision of transforming the fundamentals of intellectual property licensing through providing better ways to share patented technology.

Before joining Marconi in March 2020, Micky was Chief Patent Counsel for Microsoft, managing the Microsoft patent group since 2012. Micky managed a team of over one hundred patent professionals who were primarily responsible for outbound and inbound intellectual property licensing, patent strategy, patent acquisitions and divestitures. He also managed patent preparation and prosecution of patents and was responsible for Microsoft's conflicts, indemnification and prelitigation practice. During his time, Microsoft had a significant patent licensing business resulting in significant revenue for the company, as well as placement of Microsoft products on Android based mobile devices.

Prior to Microsoft, Micky served for 13 years as Vice President of Intellectual Property Strategy at Qualcomm in San Diego, California. There, Micky was responsible for establishing the company's 4G patent portfolio as well as intellectual property aspects of Qualcomm's mergers and acquisitions practice. As part of his time with Qualcomm, Micky was based in Munich, Germany where he managed the company's patent opposition practice.

Micky holds a BS in Electrical Engineering from Marquette University ('89), an MS in Electrical Engineering from George Washington University ('93) and a JD and LLM from the University of New Hampshire ('97), where he continues to work as the Director of Intellectual Property.

Micky served as President of Marquette Alumni Board, which he has been on since 2016. In addition, Micky is on the Marquette University Board of Trustees since 2019. Micky has served on the Board of the Intellectual Property Owners (IPO) since 2012.



**PETRO TERBLANCHE** has a successful track record in the strategic and operational management of technology intensive organizations. She has played a key part in the design and implementation of South Africa's biotechnology strategy. She holds the position of Managing Director of Afrigen Biologics (Pty)Ltd based in Cape Town, South Africa. Afrigen hosts the global mRNA technology vaccine Hub under the COVAX initiative and has a mRNA Covid 19 vaccine candidate in development as part of a global program to build capacity and capabilities in LMICs to design, develop and produce mRNA vaccines. Petro also holds a part time position as Professor in the Faculty of Health Sciences at the North-West University. A considerable part of her career was in research, development and innovation at the South African Medical Research Council (SAMRC) as well as the Council for Scientific and Industrial Research (CSIR). She has held and holding several strategic public and private sector Board positions in SA as well as the position as President of the Stakeholders Organization for the Global Alliance for TB Drug Discovery and Development (2007-2010). She has several qualifications which include: a Master of Science and a Doctor of Science in Medical Oncology from the University of Pretoria, post-doctoral she was a visiting scientist at Harvard University School of Public Health and thereafter, completed a Management of Technology program at Massachusetts Institute of Technology in addition to several management and leadership programs from leading institutions globally. Prof Terblanche is the author of more than 200 scientific publications and conference papers in public health. She was recently acknowledged as one of the legends of science by the Academy of Sciences South Africa.

# CLE: Impact of IP Rights on Development and Distribution of Novel Medical Treatments | Friday, September 30, 2022



**RICHARD WILDER JD '84** started his professional life in engineering and then studied law — with a particular focus on intellectual property law. His law practice evolved from a focus on patent law in private and corporate practice, to teaching, and to taking on increasingly responsible policy positions in government, intergovernmental organizations and in the private sector. Over the past two decades his focus has been on global public health law — including establishing organizations and leading the development of agreements to enable the development, manufacture and distribution of drugs, vaccines and diagnostics intended for global use.

A common thread running through Mr. Wilder's work in recent years has been enabling access to drugs, vaccines, and diagnostics with a particular focus on access by affected populations in low and middle-income countries. His work also addressed how to ensure access to the artifacts of scientific research, including published materials, data, software code and biological materials. When he led the IP Policy Team at Microsoft, access to source code and related license structures and business models was driving the intense, global debate on intellectual property and the role of open-source software in the development and distribution of software products. While serving as a legal advisor to the Global Health Program at the Bill & Melinda Gates Foundation, Richard led the development of the open access policy for publications arising from work funded by the foundation. The policy won the SPARC Innovator Award in 2015. As General Counsel and Director, Legal and Business Development at the Coalition for Epidemic Preparedness Innovations, he directed the legal and business development affairs of CEPI during its initial start-up phase and through the first two years of the response to the COVID-19 pandemic. This work included careful and intense engagement on how to ensure equitable access to vaccines against COVID-19 on an equitable basis — a work that is still in progress. Richard also served as a committee member of the Roundtable on Aligning Incentives for Open Science convened by the National Academies of Science, Engineering and Medicine. He is also experienced with the international public law aspects of intellectual property and access, including as a director at a UN Agency (the World Intellectual Property Organization) and on in treaty negotiations on behalf of the US Government.

Mr. Wilder is now a consultant to companies, non-profit organizations, and governments, serves on the Board of the Public Library of Science, and is a Senior Scholar at the O'Neill Institute for National and Global Health Law of Georgetown Law. He writes and speaks often on matters of law, governance, and science — especially in the life sciences sector. He also serves on a variety of advisory panels, including having served as a committee member of the Roundtable on Aligning Incentives for Open Science convened by the National Academies of Science, Engineering and Medicine.

**JUDGE KRISTIN SPATH JD '85** has been on the Circuit Court bench for 11 years, and recently took Senior Active Status. Judge Spath graduated from Franklin Pierce Law Center in 1985. She started legal career as a State Public Defender and then was appointed Deputy Clerk of Merrimack County Superior Court and worked there for 5 years. After working at Merrimack Superior Court, she went on to work as a Federal Public Defender, and then spend 13 years at the NH Department of Justice, first as the Chief of the Consumer Protection Bureau and then as the Chief of Staff for the 8 years prior to being appointed to the Bench. Judge Spath was recently awarded the Justice William A Grimes award presented by the New Hampshire Bar association for Judicial Professionalism. Her biography for the award noted that her compassion and humor. Judge Spath treats everyone in her courtroom with dignity, kindness, and respect, and makes them feel heard.



**JUDGE CHARLES "CHUCK" TEMPLE JD '85** is a 1982 graduate of the University of New Hampshire and received his Juris Doctorate in 1985 from UNH Franklin Pierce School of Law. He practiced at Upshall, Cooper and Temple, P.A. from 1985-2003, served as the Director of the Criminal Practice Clinic at UNH School of Law from 2003-2014, and has been an Associate Justice on the New Hampshire Superior Court since 2014. He continues to serve as an Adjunct Professor at the law school, teaching Trial Advocacy. Judge Temple has also served as Chair of the Public Employee Labor Relations Board and on the Committee for Cooperation with the Courts.
