HONORARY DEGREE RECIPIENTS

STEPHEN DUPREY

Owner, Duprey Companies

Stephen Duprey is a prominent New Hampshire developer known for his real estate projects and nonprofit support. His business began in the 1980s with affordable and government-subsidized housing statewide and since then he has built, owned and managed numerous properties including five hotels and the Grappone Conference Center, the region's largest conference center. Duprey was elected to the N.H. state legislature in 1972 at the age of 18 where he served two terms. He was a senior advisor for John McCain's 2007-2008 presidential campaign. Duprey has played a key role in Concord's redevelopment, including revitalizing Main Street and preserving its historic buildings. Currently, he is working on Arts Alley, a multi-use eating and entertainment venue in downtown Concord. He also chairs the Pease Development Authority and serves on several nonprofit boards.

BRADLEY OLSON

Partner at Barnes and Thornburg, LLP

Bradley Olson began his career as a patent attorney and is currently a partner with the law firm of Barnes & Thornburg, LLP where he advocates and protects the rights of businesses and individuals. He also has extensive experience in various facets of patent and trademark litigation, both within the U.S. and across multiple European countries. Olson has represented clients in major intellectual property disputes, appearing before the International Trade Commission. He is the former national chairman of the Swedish-American Chambers of Commerce of the United States and was awarded a knighthood in the Swedish Royal Order of the Northern Star for achievements in promoting cultural and business exchange between the U.S. and Sweden.

He completed a Juris Doctor degree in 1994 from UNH Franklin Pierce School of Law.

Jake Sullivan is a policy expert and educator. Sullivan was a Senior Fellow at the Carnegie Endowment for International Peace and held teaching positions at Dartmouth College and Yale Law School. He co-founded National Security Action and advised various foreign policy organizations. In August 2025, Sullivan will join the University of New Hampshire Franklin Pierce School of Law as a Senior Fellow.

HISTORICAL NOTES

Commencements in America began at Harvard University circa 1640. Early ceremonies were patterned after those of Oxford and Cambridge, England. Since then, American colleges and universities have added their own trappings, in many cases making the occasion more festive.

The caps, gowns and hoods of our graduates in the procession represent a tradition of academic dress that began in the 12th century when the stone buildings, which housed medieval universities, were not known for warmth. The gowns are an adaptation of clerical garb.

A scholar's academic hood is more than elegant and colorful attire; it denotes degree, field and alma mater. The band of velvet circling the outer edge of the hood varies in width according to the highest degree attained: narrow for the bachelor degree, medium for the master, and broad for the doctorate. The color represents the field of scholarship: law, purple; arts and letters, white; engineering, orange; science, gold; philosophy, blue; etc. The hood is lined with the colors of the institution attended by the wearer.
